Owner privileges (In the period when the owner is not renounced)

- Owner can authorize / unauthorize addresses.
- Owner can change maximum token amount per wallet.
- Owner can withdraw BNBs to the marketing receiver address.
- Owner can airdrop.
- Authorized addresses can call triggerManualBuyback that's initiate buyback.
- Authorized addresses can clean buyback multiplier.
- Authorized addresses can change auto buyback settings.
- Authorized addresses can change buyback multiplier settings.
- Authorized addresses can include in and exclude from dividends.
- Authorized addresses can include in and exclude from fee.
- Authorized addresses can include in and exclude from maximum token amount per wallet.
- Authorized addresses can change liquidity, buyback, reflection, marketing fees.
- Authorized addresses can change autoLiquidity and marketing fee receivers.
- Authorized addresses can change swap threshold and enable / disable swap.
- Authorized addresses can change target liquidity values.
- Authorized addresses can change distribution criteria.
- Authorized addresses can change distribution GAS.

Conclusion

Smart contracts do not contain severity issues! Smart contracts contain owner privileges! Liquidity pair contract's security is not checked due to out of scope.

Liquidity locking details NOT provided by the team.
